LEGAL PRACTITIONERS (HOURLY EXPENSE RATES FOR PURPOSES OF
TAXING PARTY AND PARTY COSTS) RULES, 2018

IN EXERCISE of the powers conferred by section 44 of the Legal Education and Legal Practitioners Act, 1, SAMUEL BATSON TEMBENU, SC, Minister of Justice and Constitutional Affairs, in consultation with the Chief Justice, make the following Rules

1. These Rules may be cited as the Legal Practitioners (Hourly Expense Rates for Purposes of Taxing Party and Party Costs) Rules, 2018. Citation

2. The hourly rates, for purpose of taxing Party and Party Costs, shall be as follows Hourly
expense rates

(a) *Counsel* of less than 10 years standing K30,000.00

(b) Council of more than 10 years standing K40,000.00
