CUSTOMS AND EXCISE (TARIFFS) (AMENDMENT) ORDER, 2020

IN EXERCISE of the powers conferred by section 83 (1) of the Customs and Excise Act, I, JOSEPH MATHYOLA MWANAMVEKHA, Minister of Finance, Economic Planning and Development, make the following Regulations-

1. This Order may be cited as the Customs and Excise (Tariffs) Citation (Amendment) Order, 2020.

2.--(1) The Customs and Excise (Tariffs) Principal Order is amended in Amendment Part II of the Fifth Schedule, by deleting paragraph (2) and replacing therefor of the Fifth with the new paragraph (2)---

Schedule to the Customs and Excise (Tariffs) principal Order.

"2. Pursuant to section 83 (1) of the Act, there shall be charged, levied, collected and paid in respect of the goods imported into Malawi
