MALAWI GAMING BOARD

Announcement on the award of a licence to African Gaming International to operate a Casino in Lilongwe

The Malawi Gaming Board hereby wishes to announce that it has awarded a licence to African Gaming International (AGI) to operate a Casino in Lilongwe.

In June 2014, the Malawi Gaming Board (MGB) advertised and called for expressions of interest from interested parties to operate a Casino in Lilongwe. The deadline for the receipt of the applications was the 30th of September 2014.

The Bids were invited on the basis of a "Request for Proposals" (RFP) document and it was made known to the Bidders that the bids would be rigorously evaluated in accordance with the processes set out therein. The RFP provided that the MGB was specifically looking for an interested party to undertake Casino development and management in the city of Lilongwe.

Pursuant to the advertisement that was flighted in the local print media and sent to all of Malawi's diplomatic stations, the MGB received expressions of interest from three companies. However only Africa Gaming International (AGI) submitted a bid for the MGB's consideration. After evaluation of AGI's proposal, it was decided that the company had satisfied the requirements for the award of a Casino Licence as stipulated in the Gaming Act. The Malawi Gaming Board has therefore issued a licence to AGI for the next seven years beginning 1st of April, 2015.

AGI has identified premises within the Gateway Shopping Mall for the development of the Casino. Further, the Lilongwe City Council, within whose jurisdiction the Casino shall be developed, has raised no objections on the proposed location of the Casino. The licence allows AGI to conduct various specified games in the casino subject to conditions that have been attached to the licence.
