MALAWI ELECTORAL COMMISSION

BY-ELECTIONS ORDER

(Under section 23 (2) of the Local Government Elections Act, as read with Section 147 of the Constitution of the Republic of Malawi)

WHEREAS it is provided in the Constitution that the Commission shall organise, conduct and supervise elections for local councillors for local government authorities;

WHEREAS it is provided under the Local Government Elections Act that when a councillor dies, a by-election shall be held:

WHEREAS it is provided in Local Government Elections Act that the Commission shall appoint Returning Officers with respect to every ward;

WHEREAS it is provided under the Local Government Elections Act that the Commission shall appoint the place, date and time for the receipt of nomination papers from candidates by Returning Officers in respect of

WHEREAS it is provided under the Local Government Elections Act that candidates for the office of the councillor shall pay such sum of money as fixed by the Commission on nomination to be tendered together with nomination papers;

WHEREAS it is provided under the Local Government Elections Act that all political parties and candidates shall have the right to campaign in public in an election and that supporters thereof shall either alone or in common with others enjoy complete and unhindered freedom of peaceful assembly in campaigning in an election;

WHEREAS it is provided under the Local Government Elections Act that a voters register shall be open for updating:

NOW THEREFORE. The Commission issues notice for the purposes of Local Government By-elections by declaring as follows.—

- 1. That by elections shall be conducted on 25th August, 2015 in the following wards and councils—
 - (a) Luchenza Ward in Luchenza Municipal Council;
 - (b) Zomba City Central Ward in Zomba City Council;
 - (c) Msikisi Ward in Mangochi Town Council;
 - (d) Chibanja Ward in Mzuzu City Council;
 - (e) Khwawa Ward in Karonga District Council.
- 2. That the Commission has appointed Returning Officers as indicated in the Schedules 1 to 5.
