Replacement and rule 21 of the Disciplinary Committee Rules of Procedure, 2015 2. The Disciplinary Committee Rules of Procedure, 2015, are amended by deleting Rule 21 and substituting therefor the following new rule—

“circulation and publication of list of matters before the Committee” 21. The Committee may—
(a) circulate the list of matters before it to the membership of the Society; and
(b) publish for general information, the recommendations that the Committee has submitted to the Attorney General in respect of any matters before the Committee.
