### MALAWI ELECTORAL COMMISSION

#### BY-ELECTIONS ORDER

(Under sections 36 and 100 (3) (b) & (4) of the Parliamentary and Presidential Elections Act as read with section 63 1(b) and (2) of the Constitution of the Republic of Malawi)

(Under section 23 (2) of the Local Government Elections Act)

WHEREAS it is provided in the Constitution that the Commission shall organise, conduct and supervise Parliamentary By-Elections and Local government By-Elections to fill vacant seats in the National Assembly and Local Councils;

WHEREAS it is provided that the Commission shall conduct fresh elections pursuant to an order of the court declaring that a Member of the National Assembly was not duly elected;

WHEREAS it is provided under the Parliamentary and Presidential Elections Act and Local Government Elections Act that a voters' register shall be open for updating;

WHEREAS it is provided under the Parliamentary and Presidential Elections Act that the Commission shall appoint the place, date and time for the receipt of nomination papers from candidates by Returning Officers in respect of each constituency and ward;

WHEREAS it is provided under the Parliamentary and Presidential Elections Act and Local Government Elections Act that candidates for the office of National Assembly shall pay such sum of money as fixed by the Commission on nomination to be tendered together with nomination papers;

WHEREAS it is provided under the Parliamentary and Presidential Elections Act and Local Government Elections Act that all political parties and candidates shall have the right to campaign in public in an election and that supporters thereof shall either alone or in common with others enjoy complete and unhindered freedom of peaceful assembly in campaigning in an election;

NOW THEREFORE, The Commission issues notice for the purposes of Parliamentary as well as Local Government By-elections by declaring as follows—

1. That by-elections shall be conducted on 6th June, 2017 in the following constituencies and ward—

- Lilongwe Msozi North Constituency in Lilongwe District Council
- Lilongwe City South East Constituency in Lilongwe City Council
- Mtsiliza Ward in Lilongwe City Council
- Mayani North Ward in Dedza District Council

2. That the update of the voters' register shall take place from 27th April to 1st May, 2017 from 8.00am to 4.00pm on each day in the centres as outlined in the Schedule 1 to 4.

3. That the Commission has appointed 12th May, 2017 as the day on which the Constituency and Ward Returning Officers shall receive nomination papers from candidates wishing to stand for the office Member of National Assembly and Local Council from 8.00 a.m. to 4.00 p.m. at the following places—

- Mwatibu TDC for Lilongwe Msozi North Constituency
- Chiwoko TDC for Lilongwe City South East Constituency
- Mtsiliza School for Mtsiliza Ward
- Tchesa TDC for Mayani North Ward

Nomination papers will be made available at the District Commissioner's office and the Constituency and Ward Returning Officer's offices from 20th April, 2017. Aspiring candidates in the constituencies and wards and/or their agents may collect the nomination papers on any other day from that date so long as they are presented back to the Returning Officer on 12th May, 2017.

4. That the Commission further orders that fees payable on deposit of nomination papers shall be as follows—

- MK200,000 for male candidates and MK150,000 for female candidates for Parliamentary Elections.
- Non-Refundable nomination fees of MK20,000 for male candidates and MK15,000 for female candidates for Local Government Elections

5. That Campaigning in the by elections shall close on 4th June, 2017 at 6.00 a.m.
