## MALAWI GAMING BOARD

#### Public Notice

## 1.0 Introduction

The Malawi Gaming Board (MGB) is a body corporate established under section 3 of the Gaming Act, 1996 (the Act). The MGB was established to enforce the law relating to the regulation of gaming; for the control and licensing of gaming premises; for the imposition and recovery of a tax on gaming and for all matters connected with and incidental to the same.

## 2.0 Licensing

All licences issued under the Gaming Act expire a year following the date of issue. The MGB has the power to issue the following licences...

- (i) Casino Licences;
  - (ii) Gaming Machine Operators Licences;
  - (iii) Gaming Machine Site Licences;
  - (iv) Bingo operator licences;
  - (v) Junket agent licences;
  - (vi) Manufacturer licences;
  - (vii) Maintenance licences;
  - (viii) Supplier licences:
  - (ix) Wide area progressive gaming licences;
  - (x) Any other licences as determined by the Board.
