

GENERAL NOTICE NO. 6

MALAWI ELECTORAL COMMISSION

GENERAL ELECTION ORDER

(Under section 36 (1) of the Parliamentary and Presidential Elections Act, and under section 28 (1) of the Local Government Elections Act)

WHEREAS it is provided by law that the Electoral Commission (the "Commission") shall organize, conduct and supervise Parliamentary, Presidential and Local Government Elections;

WHEREAS it is provided under the Parliamentary and Presidential Elections Act and under the Local Government Elections Act that the Commission shall appoint the place, date and time for the receipt by the Returning Officer of the nominations of candidates;

WHEREAS it is provided under the Parliamentary and Presidential Elections Act and under the Local Government Elections Act that all political parties and candidates shall have the right to campaign in public in an election;

NOW THEREFORE, the Commission issues notice and declares that-

- 1. General elections shall be conducted on 21st May, 2019 throughout Malawi in all constituencies, wards and polling stations from 6 a.m. to 6 p.m.
- 2. The Commission has appointed Constituency and Ward Returning Officers as appearing in Schedule 1
- 3. The Commission has appointed the dates beginning 4th February, 2019 to 8th February, 2019 as the period during which nomination papers shall be received from candidates by the Returning Officers as follows—

Member of Parliament and Local Council

3.1. Constituency and Ward: Returning Officer shall receive nomination papers from candidates wishing to contest for the office of Member of Parliament and Local Council from 4th February, 2019 to 8th February, 2019 from 8:00 a.m. to 4:00 p.m. on each day at the places outlined in Schedule 1 Nomination papers will be made available for collection by aspiring candidates or their representatives from District Commissioner's office and the Constituency and Ward Returning Officer's offices for independent candidates and

Secretaries General for those who will be sponsored by political parties from 3rd January, 2019:

- 3.2. The Chief Elections Officer shall receive nomination papers from candidates wishing to contest for the office President of theRepublic of Malawi at COMESA Hall in Blantyre from 4th February, 2019 to 8th February, 2019. Nomination papers will be made available for collection by aspiring candidates or their representatives from the Electoral Commission Offices at Blantyre from 3rd January, 2019.
- 4. Campaigning shall commence on 19th March, 2019, and shall close on 19th May, 2019, at 6:00 a.m.
