LANDS ACQUISITION AND COMPENSATION ACT

(Cap. 58:04)

Notice of Cut off date for Land and Property Surveys for Land Acquisition

WHEREAS Government is developing irrigation, agriculture in the districts of Chikwawa and Nsanje, on the west bank of the Shire River under the Shire Valley Transformation Programme which is being implemented with support from the World Bank, the African Development Bank, the Global Environment Facility and the Government of Malawi;

WHEREAS Government is developing 43,370 hectares of land under the Shire Valley Transformation Programme in three phases and under the First Phase, land covering 22,280 hectares of irrigable land will be supplied

- (a) the Main Canal 1, which is from the intake to Chainage at Supuni Village (covering 33.7 kilometres);
- (b) the Main Canal 2, which is from Chainage at Supuni Village to Lengwe National Park (covering 18.4 kilometres); and
- (c) the Main Canal 3, which branches at Supuni Village going towards Nchalo Estate (covering 10.6 kilometres);

WHEREAS the First Phase shall include the construction of other structures and access roads to enable irrigation under gravity water supply system:

- I, SYMON VUWA KAUNDA, Minister of Lands, Housing and Urban Development, by powers conferred by section (6) of the Lands Acquisition and Compensation Act (Cap. 58:04), as Minister of Lands, Housing and Urban Development, on the recommendation of the Minister of Agriculture, Irrigation and Water Development, make the following Notice to all local leaders, all community members and the public in general as
 - (a) the Last Day for surveys of the affected land and property for the project was Sunday, 15th July, 2018;
 - (b) all persons with land related queries or anomalies met with members of the Project Team to finalize the surveys between 29th June, 2018 and 1st July, 2018;
 - (c) after the cut-off date of 15th July, 2018, no permanent developments or improvements shall be allowed within the demarcated area and way leave; any new property constructed within the demarcated and surveyed area after 15th July, 2018 shall not be compensated for land acquisition for the Shire Valley Transformation Programme:
