#### **Public Notice**

#### 1.0 Introduction

The Malawi Gaming Board (MGB) is a body corporate established under section 3 of the Gaming Act, 1996 (the Act). The MGB was established to enforce the law relating to the regulation of gaming; for the control and licensing of gaming premises; for the imposition and recovery of a tax on gaming and for all matters connected with and incidental to the same.

#### 2.0 Licensing

All licences issued under the Gaming Act expire a year following the date of issue. The MGB has the power to issue the following licences-

(i) Casino Licences:

(ii) Gaming Machine Operators Licences;

(iii) Gaming Machine Site Licences;

(iv) Bingo operator licences;

(v) Junket agent licences;

(vi) Manufacturer licences;

(vii) Maintenance licences;

(viii) Supplier licences;

(ix) Wide area progressive gaming licences;

(x) Any other licences as determined by the Board.
