ELECTRICITY SUPPLY CORPORATION OF MALAWI LIMITED

Electricity Act No. 22 of 2004

Notification intention to Construct a 33 KV Distribution Overhead Power Line from Nanjoka Substation to New Senga Bay Substation

In accordance with section 39 of the Electricity Act, No. 22 of 2004, notice is hereby given that Electricity Supply Corporation of Malawi (ESCOM) Limited intends to construct a 33 KV Distribution overhead power line (hereinafter called "the line") from Nanjoka Substation to New Senga Bay substation in Salima district.

1. Particulars of the line are as follows—

Length: 34 Km

Way leave width: 15m (7.5 meters going either side from the Centre conductor)

Voltage: 33kV (33000 volts)

2. Description

The proposed power line will start from existing Nanjoka substation going westwards, crossing M5 road (road leading to Salima Boma) and at 80 meters, turns southwards running parallel to M5 road until it reaches 1 km and turns at 90 degrees southwestwards and runs parallel to earth road leading to Thuma forest and at 190 meters, turns again at 90 degrees and goes southwards in group village headman Sadzu. It turns an angle of 30 degrees South east and moves towards East until at 3.9 km, it crosses underground existing 132 kV overhead Line and immediately runs overhead, crosses Lilongwe River at 4.1 km and turns south east in group village headman Mwazawala and runs parallel to existing 33/132 KV Overhead line until at 5.8 km, it turns south east in sub traditional Authority Chisamba and then moves eastwards and at 5.9 km crosses 33 kV Overhead line and turns eastwards in Mwakhundi village and then moves south east and then turns southwards until it crosses Linthipe River at 11.1 km in group village headman Kasambwa and makes an angle of 85 degrees towards south eastwards in group village headman Chimbanga and then turns southwards and then makes an angle of 95 degrees again south east in group village headman Liganga until it turns southwards at 110 degrees and at 13 km, it crosses Salima—Chipoka road (near Kamuzu bridge), passing through Mkatandila, Kumtombwe and in group village headman Kawanga villages. It then turns south east and crosses railway line at a distance of 15.3 km and moves eastwards at 85 degrees and continues moving parallel the railway line until at 110 degrees, it turns southwards, moving towards Linthipe River and at 17 km, it crosses again Linthipe River in group village headman Daniel and it then turns 190 degrees southwards before it turns again 60 degrees eastwards at a distance of 17.3 km in group village headman Chimwavi and then turns south eastwards until it crosses road leading to Maganga trading centre and at 21.2 km turns south east into Mkumpha village and moves again in the same direction into Kachere village and crosses Maganga road again at an angle of

40 degrees where it turns south eastwards crossing under pass existing 11 kv OH supply to Maganga trading centre. It then moves southwards and turns south east and then North East and then turn southwards into Mtende village from where it moves south east and then North east into Fisi village and then again moves south east up to 24.4 km where it crosses road to Milimbo. It turns north east into Mulande and Chilombo villages and then turns northwards into group village headman Mbulu, crossing Kaseka dambo area. It turns eastwards up to 26.6 km where it turns north east and then eastwards passing through Kundayi, Losiyati, Moyo and Mackenzi villages up to Mpatsanjoka dambo area where it turns again north east. At 31.7 km, it turns eastwards moving parallel to Senga Bay road and crosses Mpatsanjoka stream and continue moving eastwards but still moving parallel to existing road and crosses the road at 33.1 km where it moves eastwards and parallel to Senga Bay road until it goes into proposed Senga Bay substation at 34 km.

Any owner, lessee, or occupier over whose land the intended line passes, is informed that plans for construction are available for inspection at ESCOM's planning offices in Blantyre, Lilongwe and Mzuzu. Route plans can be inspected at Lilongwe District Commissioner and District Councils offices at any time during normal business hours from 07:30 am to 05:00pm.

Notice is further given that objections by any owner, lessee or occupier of land affected by the intended Distribution line must be served on ESCOM Ltd in writing thirty (30) days from the date hereof at the offices of ESCOM.

Notification of Intention to Construct an 11 kv Distribution Overhead Power Line from Bunda Turn Off (Tsabango Substation) through Zankutu Trading Centre, Katete Farm to Likuni Roundabout

In accordance with section 39 of the Electricity Act, No. 22 of 2004, notice is hereby given that Electricity Supply Corporation of Malawi Limited (ESCOM) intends to construct an 11kV Distribution overhead power line (hereinafter called "the line") from Bunda Turn Off Substation through Zankutu Trading Centre to Likuni Roundabout along the Western By-pass road in Lilongwe District.

1. Particulars of the line are as follows—

Length: 11.6 Km

Way leave width: 15 meters (7.5 meters going either side from the centre of the line)

Voltage: 11kV (11000 Kilovolts)

2. Description

From Bunda Turn Off, the power line starts from Bunda Turn-Off Substation (also referred to as Tsabango substation in other project documents) on the western side, crossing a 66kV overhead line from Nkula Hydro Power Station (underground cable) and 11kV overhead line going to LUANAR and turns westwards at 300 meters near Bunda Turn Off Total Filling Station. It further turns again westwards and at about 300 meters turns northwards at right angle and crosses tarmac road to LUANAR where it makes a sectional angle and moves Northwest parallel to Western By-pass road into Ngwata village Traditional Authority Tsabango Lilongwe District. It then crosses Nyakhulu stream into Buluzi village, crosses the roads to Pondamale, Guzani and Kwantundu villages and turns northwards in Senior Group Kachala village until it crosses again another road to Pondamale, crossing bundled 11kV overhead line near HUA-LIAN Company Limited and still moving parallel to Western By-pass road until it reaches Zamkutu Trading Centre where it continues moving northwards crossing the road leading to Pondamale, then the road to Chigwilizano

Trading Centre near Katete Farm where it makes a T/OFF crossing Western By-pass road and divert to the eastern side along Katete Farm commercial plots and parallel to the road to Mitengo Trading Centre and terminates at a proposed Transformer site 350 meters from the T-OFF.

From T-off, the power line continues running northwards and parallel the Western Bypass Road and outside Katete Farm wired fence and within road reserve pillars until it reaches a distance of 10.2 Km where it crosses 66kV Over Head Line, then diverts to the right hand side of the road and continues running northwards and parallel to Western bypass road and crosses Lilongwe river. After crossing Lilongwe river, it runs towards Likuni Roundabout and then divert North Eastwards, crosses Chankhandwe stream and continue running until it crosses the road to Likuni, connecting into existing 11kV Over Head Line at a vertical angle.

Any owner, lessee, or occupier over whose land the intended Distribution line passes, is informed that plans for construction are available for inspection at ESCOM Limited's Planning Offices in Blantyre, Lilongwe and Mzuzu. The line covers two Traditional Authorities (Kuntaja and Kunthembwe) It passes through the following villages in their order from Nkula Substation: Nkula, Katchakwala, Huwa, Mwita, Dick, Gwede, Mkwana, Thanganyika, M'gundo, Kuntaja, Golowa, Chiwalo, Mpasuka, Nkata, Gavie and Kapitawo.
