As a consequence of the conviction of Councilor Michael Ngasalayumo MWANGONDE of Kaporo Ward in Karonga North Constituency; Councilor Smart MWAKAYIRA of Rukuru Ward in Karonga North-West Constituency and Councilor Steven Mukundanji SIMSOKWE of Chilanga Ward in Karonga North-West Constituency of offences involving dishonesty by the Magistrate Court sitting at Karonga on 1st September 2023, the seats formerly held by the mentioned members of Karonga District Council became vacant;

Pursuant to section 47 of the Presidential, Parliamentary and Local Government Elections Act (the Act), the Malawi Electoral Commission (the Commission) on 17th November 2023 and on 1st DECEMBER 2023 published a notice in the Gazette publicizing the vacancies and stating reasons for the vacancies. Further, the Registrar of the High Court has given notice to the Commission of the fact that the above-mentioned persons, to whom the notice published by the Commission relates, have not presented any petition to the High Court challenging the declaration that they ceased to be members of Karonga District Council;

Now, in accordance with section 36 (1) (a) (ii) of the Act, the Commission hereby declares that-

1. Local government by-elections shall be held in KAPORO WARD in Karonga North Constituency, RUKURU WARD in Karonga North-West Constituency and CHILANGA WARD in Karonga

North-West Constituency on 26TH MARCH 2024 in accordance with the Presidential, Parliamentary and Local Government Elections Act, 2023 from 6 AM to 4 PM;

- 2. Registration of voters shall be conducted from 19TH FEBRUARY 2024 to 25th February 2024 at all Registration Centres in the respective wards from 8 AM to 4 PM on all days.
- 3. Copies of the voters' register shall be posted at all registration centres where registration of voters took place for purposes of verification of entries by voters, representatives of political parties, independent candidates and observers from 2ND MARCH 2024 to 3RD MARCH 2024 from 8 AM to 4 PM
- 4. The receipt of the nominations of candidates, in respect of each of the wards shall take place on 6TH MARCH 2024 from 8 AM to 4 PM at the following venues:
